Admission Agreement 2024-2025 School Year

Celebration Life Academy is here to provide a safe, comfortable, learning environment for the school hours of 8:50am-2:30pm Monday through Friday.

- ◆ **\$100 Annual Registration Fee (due at registration). \$400.00 Student Fees (due July 1st)**
Registration fee is payable at the time application is made. Student fees are due as stated above and are non-refundable fees unless CLA cannot accommodate your student(s). All fees are due annually upon re-enrollment.
- ◆ **Multiple Child Discount**
Families with more than one child attending Celebration's school/daycare ministries will receive a 5% per child discount.
- ◆ **Multiple Program Discount**
Students enrolled in CLA TK-4th Grade may receive a 30% discount on Before and After School Care fees.
- ◆ **Snacks & Lunch**
Snacks and Lunch are **not provided** for students, and must be brought from home.
- ◆ **Tuition Payments**
All families enrolled in CLA will need to sign up for our automated payment processing service, Tuition Express. The annual tuition fee is \$7,000 and may be made in one annual installment in the month of August (for a 5%) discount or in 10 monthly payments of \$700. made August-May. Payments are processed on, or about, the 5th of each month, unless other arrangements are made with the CKM/CLA Accountant. Payments made by credit card incur a 2.5% service fee via Tuition Express. ACH payments incur NO additional fees. Additionally, any insufficient fund fees incurred will be charged to the client.
- ◆ **Fee Increase**
Parents will receive a 30 day written notice prior to annual fee increases.

◆ **Late Pick-Up Charge**

School ends promptly at 2:30pm, unless it is a scheduled early release day. Students not picked up by 2:40pm will be checked in our after school program and may be assessed a **\$1.00** per minute late charge. Please Note: Our before and after school care program is licensed with Community Care and requires separate enrollment/paperwork. CLA does NOT offer drop-in daycare.

◆ **Withdrawals**

A withdrawal may be implemented by completing a Notification Form, and submitting it to the Principal's Office a minimum of 30 days in advance of the requested last day of attendance. The 30 days is determined from the day that the form is received by the Office. Your account will be charged or refunded accordingly.

◆ **Termination**

Termination is caused by, but not limited to:

1. Omission or misrepresentation in filling out admission forms.
2. Repeated inappropriate behavior and/or language.
3. Failure to meet the terms of tuition.
4. Inability of child and church to obtain mutual benefit from the clubs at Celebration.
5. Failure to comply with regulations covered in the Parent's Handbook.
6. The enrollment of a child having a physical, emotional, or psychological disorder that is beyond the capabilities and/or expertise of the teaching staff.

I hereby authorize Celebration to call an emergency ambulance in case of accident or acute illness, and to arrange for necessary emergency medical care, in case I am not immediately available. Any qualified physician, called by Celebration, may treat and do whatever is necessary for the health and well being of my child. It is understood that a conscientious effort must be made to notify me (parent/guardian) before such action will be taken.
